

HISTORY

During the early 1900s the field-meadow area of the parcel was ditched to drain the meadow, then hayed for two years by the owner Mr. Brewster. According to Larry Brewster of Dana, his family had a two story on the adjacent 120 acres, and Mr. Brewster worked at the Pondosa Sawmill for several years. In 1966, a right-of-way was granted to Western Area Power grid and the power line R/W was cleared over the western part of the property. In 1977, the entire ownership was burned over by the "Pondosa Fire," which was lightning caused during the severe drought year of 1977.

The property was reforested with Ponderosa Pine in the 1980s and natural regeneration of Lodge Pole Pine, Jeffrey Pine and Aspen occupy the property except for the 60 acre grassland area, which is flooded each spring.

Mr. and Mrs. Belden bought the property in 2005 and have made several improvements including building a cabin, grassland and shed.
