

HISTORY

Jackson is the largest of CAL FIRE's ten demonstration state forests. The area has a long history of logging which began in under private ownership 1862 then evolved into sustainable harvesting after the State's purchase of the property in 1947. Today, more forest growth occurs each year than is harvested. The most common tree on the forest is coast redwood, but visitors will also find Douglasfir, grand fir, hemlock, bishop pine, tanoak, alder, madrone and bay myrtle.

FIELD DAY SCHEDULE OVERVIEW

The tour will begin in the Caspar Watershed Experiment, a paired watershed study begun in 1962 to better understand the effects of forest practices on watershed and ecological processes. Elizabeth Keppeler, lead hydrologist with the USDA Forest Service Pacific Research Station, will catch us up on their multidisciplinary research, highlighting their efforts to understand legacy impacts and restoration responses. We will get to see some of the ever-evolving infrastructure and instrumentation that allows the team to intensively monitor the hydrological and sediment response to a wide variety of influences.

As we make our way up slope from the creek, the conversation will move from water to fire. Dr. Michael Jones, University of California Cooperative Extension Forestry Advisor for Mendocino, Sonoma and Lake Counties, will share recent progress made in understanding how beetles, drought and fire interact in forest ecosystems in California, and what this means for management. In the coming years JDSF will become the proving grounds as we discover how to bring disturbanceresilient management to the redwood region. This tour will be a unique chance to experience the "before" state in this multi-year management experiment.

We will then take the "scenic route" out to Highway 20 along Rd. 500, which will receive a shaded fuel break treatment in the coming years. Once again, a chance to experience the "before" state.

From Hwy 20, we will travel down Gravel Pit Rd to the Hare Creek Watershed.

There we will meet up with Anna Halligan, North Coast Coho Project Director with Trout Unlimited, who will guide us through the planning and implementation process of habitat restoration utilizing the strategic placement of large woody debris. She will also catch us up on recent development in California's "Cutting the Green Tape" initiative, which will make restoration projects more accessible and less bureaucratically burdensome to forest landowners and their partners.

Just upstream from the restoration projects is the ambitious redwood "MASAM" demonstration project. Lynn Webb, recently retired Research and Demonstration Program Manager for JDSF will introduce us to this ongoing project, where JDSF foresters implemented a practical application of a Multi Aged Stocking Assessment Model. MASAM is a method that simplified planning to insure that selection silviculture will provide continued recruitment and yield long term. A spreadsheet allows managers to design and assess density management alternatives that allocate growth potential between multiple age classes. The site we will be visiting utilized a selective harvest and precommercial thin to implement the recommendation of the model in a redwood forest.
